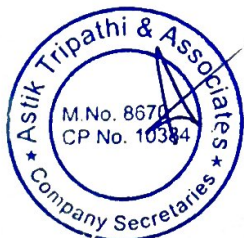




Note:
