Company from BSE Limited and offer to acquire the shares held by the public shareholders in compliance with the applicable Regulations of the SEBI Delisting Regulations. Pursuant to Regulation 8(1) of the SEBI Delisting Regulations, the IPA was filed with you on October 26, 2021. To enable to take up the proposed delisting, the Company had sought certain relaxations / exemptions from SEBI for complying with certain regulations of the SEBI Delisting Regulations. Accordingly, SEBI vide their letter dated September 30, 2021, have conveyed their approval for the exemptions sought, details of which are summarised below : (a) Exemption from the provision of Regulation 10(4)(a) of the SEBI Delisting Regulations requiring the Company to be in compliance with the applicable provisions of Securities Laws (b) Exemption from the provision of Regulation 35(1)(a) of the SEBI Delisting Regulations requiring networth of the company not exceeding Rs. 25 Crores for it to be treated as a Small Company (c) Exemption from the provision of Regulation 35(1)(c) of the SEBI Delisting Regulations requiring the Company not being suspended by any of the Stock Exchanges (d) Exemption from the provision of Regulation 35(2)(d) of the SEBI Delisting Regulations requiring obtaining written consent from the public shareholders (holding 90% or more of the public shareholding) for delisting as a Small Company 02.
